



Our Guarantee

Your new puppy is guaranteed to be free of all communicable diseases to the best of our knowledge; free from any health defects to the best of our knowledge; and is the best pet quality available. The puppy is guaranteed against communicable health diseases for a period of seven(7) days from the arrival date at your home, and congenital health problems for a period of twelve (12) months from the date of purchase.

This guarantee does not cover what is considered common breed conditions, including but not limited to: Demadex, Cherry eye, Entropion, loose hips and knees, skin allergies, elongated soft palate and autoimmune disorders.

This guarantee does not include Coccidia, Giardia, and Kennel Cough, which are common in puppies that are transported and usually caused and brought on by stress. These are easily treated by your local vet.

As of the date of delivery to your home, we guarantee the puppy has received proper vaccinations and dewormings for his/ her age and weight. The Buyer has been informed of these. Any future vaccinations and dewormings due are the responsibility of the Buyer.

A puppy with a defect must be returned to Seller to qualify for a replacement puppy. A returned puppy must be returned to the Seller in good condition, other than the specified problem, through prior arrangement with the Seller, at the expense of the Buyer. The Buyer may then qualify for a replacement puppy. This guarantee applies to the original puppy Buyer/ Owner only and is nontransferable and nonassignable to a second party.

If the puppy should become deceased within six(6) months from the date of purchase, the Buyer will pay to have an autopsy performed to ascertain the cause of death. If the cause of death is determined to be congenital in nature, all findings and reports must be sent to and agreed upon by our Veterinarian before a replacement puppy may be given. Determination whether to replace said puppy will be at the discretion of the Seller and pending availability of a replacement puppy. This guarantee does not include any health problems due to the result of any accident(s) or injury(ies) which occurred in the puppy's new home.

This health guarantee is null and void if the following terms and conditions are not fulfilled: Puppy **MUST** be examined by a licensed and fully credentialed Veterinarian

within 72 hours of the Puppy's arrival to Buyer's possession. Seller must be informed immediately of the examination results together with a copy of the examination report and/ or proof of examination. Failure to comply with all terms contained supra, will result in cancellation of this guarantee in its entirety. Costs for Veterinarian examinations and/ or medications are payable by the Buyer and shall not be covered by Seller or this guarantee.
